SWEEPSTAKES OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. PURCHASING PRODUCTS OR SERVICES FROM CALIFORNIA COAST CREDIT UNION WILL NOT IMPROVE YOUR CHANCES OF WINNING. EACH ENTRY HAS AN EQUAL CHANCE OF WINNING. The “Jungle Bells Tickets Sweepstakes” (Sweepstakes) begins 9:00 AM Pacific Standard Time (PST) on November 28, 2018, and ends 5:00 PM PST on December 12, 2018, (Sweepstakes Period). By entering this Sweepstakes, entrants accept and agree to be bound by these Official Rules. Sweepstakes void where prohibited by law. California Coast Credit Union is the sponsor of this Sweepstakes (Sponsor). This promotion is in no way sponsored, endorsed, or administered by or associated with Facebook.

WHO MAY ENTER: Entrants must be at least 18 years of age, have valid U.S. government issued identification and valid tax identification number. Credit Union employees, officials, and members of their immediate families are not eligible to participate in the Sweepstakes. Business entities are not eligible to participate. Sweepstakes is void in Puerto Rico, U.S. territories and possessions outside of the United States, and where restricted or prohibited by law.

HOW TO ENTER: Eligible entrants may enter this Sweepstakes via a Branch, Facebook, or Mail. The entry methods are described below. **LIMIT: ONE (1) ENTRY PER PERSON PER DAY REGARDLESS OF METHOD OF ENTRY.** All entries must be received by 5:00 PM PST, December 12, 2018. Multiple entries received from any person beyond this limit will void all such additional entries. **Branch Entry Method:** Visit any one of our 24 California Coast Credit Union branches and complete an entry form. Visit www.CalCoastCU.org for branch locations and hours of operation. **Facebook Entry Method:** Entrant must be a registered user of Facebook (<http://www.facebook.com>) to participate in the Sweepstakes. If entrant is not a registered user of Facebook, simply visit <http://www.facebook.com> to register for free. Qualified entrants will be required to comment on the official contest page on Facebook. **Alternative Method of Entry (AMOE):** Mail a 3” x 5” card with your first name, last name, home branch, complete address, city, state, zip code, home phone number (including area code) and email address (if any) to “Jungle Bells Tickets Sweepstakes” c/o California Coast Credit Union, Attn: Marketing Dept., PO Box 502080, San Diego, CA 92150-2080. California Coast will not verify receipt of entries for entrants. All entries submitted become the sole property of California Coast and will not be returned. Sponsor is not responsible for lost, late, misdirected, illegible, or damaged AMOE entries. All postcard entries must be received by 5:00 PM PST, December 12, 2018 to qualify.

Prize/Approximate Retail Value: FOUR (4) tickets to Jungle Bells at the San Diego Zoo. The Approximate Retail Value (the “ARV”) of the prize is \$208. Eleven (11) winners will be chosen in a random drawing on December 13, 2018 and contacted by phone or email. Odds of winning are based upon the number of entries. Based upon California Coast Credit Union’s estimate of 1,000 entries, the odds of winning any prize are 1 chance in 1,000. If any prizes remains unclaimed after 12:00 PM PST on December 14, 2018 or the winners do not meet eligibility qualifications, a second random drawing will be held. The prize will be scheduled to be picked up at any CCCU branch location. Prize is not transferrable.

Liability/General Rules: California Coast Credit Union is not responsible for any loss which may occur in connection with the “Jungle Bells Tickets Sweepstakes.” Entrants agree to hold California Coast Credit Union harmless from any liability arising from participation in the Sweepstakes or the acceptance, receipt, possession, or misuse of the prize. California Coast Credit Union and each of its officers, directors, employees, members, representatives and agents are not responsible for any negligence, claims, liability, injury, property loss, or other damages of entrants and/or winners arising from, or in connection with, acceptance, receipt, possession, or use/misuse of prizes awarded or participation in the “Jungle Bells Tickets Sweepstakes.” Prizes cannot be substituted, assigned or transferred by winners. California Coast Credit Union reserves the right to disqualify entrants who fail to follow these Official Rules or who make any misrepresentations relative to the Sweepstakes and redemption of prize.

Sweepstakes Conditions: This Sweepstakes is subject to all applicable federal, state and local laws. By participating, entrants agree to be bound by these Official Rules and the decisions of the Sponsor and waive any right to claim ambiguity in the Sweepstakes or these Official Rules. Sponsor is not responsible for lost, late, misdirected, undeliverable, illegible, or incomplete entries, whether due to system errors or failures, faulty transmissions or other telecommunications malfunctions, entries not received resulting from any hardware or software failures of any kind, lost or unavailable network connections, failed, incomplete or garbled computer or telephone transmissions, typographical or system errors and failures, technical malfunctions, or otherwise. Sponsor may prohibit an entrant from participating in the Sweepstakes or winning a prize if, in its sole discretion, it determines that said entrant is attempting to undermine the legitimate operation of the Sweepstakes by cheating, hacking, deception, or other unfair practices or intending to annoy, abuse, threaten, or harass any other entrants or Sponsor. Arbitration: Except where prohibited by law, as a condition of participating in this Sweepstakes, entrant agrees that (1) any and all disputes and causes of action arising out of or connected with this Sweepstakes or any prizes awarded, shall be resolved individually, without resort to any form of class action, and exclusively, by final and binding arbitration under the rules of the American Arbitration Association (“AAA”) and shall be held at the AAA regional office nearest the participant; (2) the Federal Arbitration Act shall govern the interpretation, enforcement, and all proceedings at such arbitration; and (3) judgment upon such arbitration award may be entered in any court having jurisdiction. Under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental, or consequential damages, or any other damages, including attorney’s fees, other than entrant’s actual out-of-pocket expenses (i.e., costs associated with entering this Sweepstakes), and entrant further waives all rights to have damages multiplied or increased.
