### “GoGreen Giveaway” CONTEST OFFICIAL RULES

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. PURCHASING PRODUCTS OR SERVICES FROM CALIFORNIA COAST CREDIT UNION WILL NOT IMPROVE YOUR CHANCES OF WINNING. EACH ENTRY HAS AN EQUAL CHANCE OF WINNING.** The “GoGreen Giveaway” (Contest) begins 12:00 AM Pacific Daylight Time (PDT) on April 1, 2025 and ends 11:59 PM PDT on April 30, 2025 (Contest Period). By entering this Contest, entrants accept and agree to be bound by these Official Rules. Contest void where prohibited by law. California Coast Credit Union (California Coast) is the sponsor of this Contest (Sponsor). This promotion is in no way sponsored, endorsed, or administered by or associated with Facebook, X, or Instagram.

**WHO MAY ENTER:** Entrants must be at least 18 years of age, a California resident, have valid government issued identification and valid tax identification number. California Coast employees, officials, and members of their immediate families are not eligible to participate in the Contest. Business entities are not eligible to participate. Contest is void in Puerto Rico, U.S. territories and possessions outside of the United States, and where restricted or prohibited by law.

**HOW TO ENTER:** Eligible entrants must complete the online quiz at [calcoastcu.org/gogreen-giveaway](https://calcoastcu.org/gogreen-giveaway). By entering the contest, entrants accept being contacted by Cal Coast through email and by phone. The entry method is described below. All entries must be received by 11:59 PM PDT, April 30, 2025. **Online Entry Method:** Eligible entrants must complete the online quiz at [calcoastcu.org/gogreen-giveaway](https://calcoastcu.org/gogreen-giveaway). **Alternative Method of Entry (AMOE):** Mail a 3" x 5" card with your first name, last name, complete address, city, state, zip code, phone number (including area code) and email address (if any) to “GoGreen Giveaway” c/o California Coast Credit Union, Attn: Marketing Dept., PO Box 502080, San Diego, CA 92150-2080. California Coast will not verify receipt of entries for entrants. All entries submitted become the sole property of California Coast and will not be returned. Sponsor is not responsible for lost, late, misdirected, illegible, or damaged AMOE entries. All AMOE entries must be received by 5:00 PM PDT, April 30, 2025 to qualify.

**Prize/Approximate Retail Value:** First place winner will receive \$500 and a voucher code for seven (7) eco-tour tickets hosted by [Ocean Connectors](#). The Approximate Retail Value (the “ARV”) of the \$500 prize and eco-tour voucher is \$1,000. Based upon California Coast’s estimate of 500 entries, the odds of winning any prize are 1 chance in 500. Prize is not transferable.

**Selection of Winners:** One (1) winner will be chosen around the date of May 5, 2025. The entry that is randomly selected by a random number generator will be selected as the winner and will receive \$500 and a voucher code for seven (7) eco-tour tickets hosted by [Ocean Connectors](#) in May, 2025. A panel of representatives from the Sponsor will judge the entries and resolve any disputes that may arise during the contest. All decisions by the panel are final. The winner will be contacted via email and through the phone number provided at the time of entry. If Sponsor is unable to contact the prospective winner within 24 hours of being contacted, or if the prospective winner does not meet eligibility qualifications, his/her prize will be forfeited and an alternate prospective winner shall be selected. The prize must be picked up either at the corporate office of California Coast Credit Union between the hours of 9:00am-5:00pm or if the prize is virtual, they may be sent electronically via the AXS app. The winner will be asked to identify their first and last name and will then be asked for proof of identification upon receiving prize.

**Liability/General Rules:** California Coast is not responsible for any loss which may occur in connection with the “GoGreen Giveaway.” Entrants agree to hold California Coast harmless from any liability arising from participation in the Contest or the acceptance, receipt, possession, or misuse of the prize. California Coast and each of its officers, directors, employees, members, representatives and agents are not responsible for any negligence, claims, liability, injury, property loss, or other damages of entrants and/or winners arising from, or in connection with, acceptance, receipt, possession, or use/misuse of prizes awarded or participation in the “GoGreen Giveaway.” Prizes cannot be substituted, assigned or transferred by winners.
