“Aztec Fan Frenzy” CONTEST OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. PURCHASING PRODUCTS OR SERVICES FROM CALIFORNIA COAST CREDIT UNION WILL NOT IMPROVE YOUR CHANCES OF WINNING. EACH ENTRY HAS AN EQUAL CHANCE OF WINNING. The “Aztec Fan Frenzy” (Contest) begins 9:00 AM Pacific Daylight Time (PDT) on February 18, 2025, and ends 12:00 PM PDT on March 24, 2025 (Contest Period). By entering this Contest, entrants accept and agree to be bound by these Official Rules. Contest void where prohibited by law. California Coast Credit Union (California Coast) is the sponsor of this Contest (Sponsor).

WHO MAY ENTER: Entrants must be at least 18 years of age, have valid government issued identification and valid tax identification number. California Coast employees, officials, and members of their immediate families are not eligible to participate in the Contest. Business entities are not eligible to participate. Contest is void in Puerto Rico, U.S. territories and possessions outside of the United States, and where restricted or prohibited by law.

HOW TO ENTER: Eligible entrants must text “Aztecs” and as well as a photo or video to (619) 500-9395. Eligible entrants may enter this Contest via the Cal Coast Phone number ((619) 500-9395) or mail. By entering the contest entrants accepts being contacted by either phone or email. The entry methods are described below. All entries must be received by 12:00 PM PST, March 24, 2025. **Text Message Entry Method:** must text “Aztecs” and as well as a photo or video to (619) 500-9395 to be entered into the drawing. **Alternative Method of Entry (AMOE):** Mail a 3” x 5” card with, your first name, last name, complete address, city, state, zip code, home phone number (including area code) and email address (if any) to “Aztec Fan Frenzy” c/o California Coast Credit Union, Attn: Community Relations Dept., PO Box 502080, San Diego, CA 92150-2080. California Coast will not verify receipt of entries for entrants. All entries submitted become the sole property of California Coast and will not be returned. Sponsor is not responsible for lost, late, misdirected, illegible, or damaged AMOE entries. All AMOE entries must be received by 12:00 PM PST, March 24, 2025 to qualify.

Prize/Approximate Retail Value: First place winner will receive a gift card to the Aztec Shops at a value of \$100. The Approximate Retail Value (the “ARV”) gift card is \$100. Based upon California Coast’s estimate of 750 entries, the odds of winning any prize are 1 chance in 750. Prize is not transferrable.

Selection of Winners: One (1) winner will be chosen on each of the following days: February 19, March 12, March 24. The entry that is randomly selected by a random number generator will be selected as the winner and will receive one (1) \$100 gift card to Aztec Shops. A panel of representatives from the Sponsor will judge the entries and resolve any disputes that may arise during the contest. All decisions by the panel are final. The winner will be contacted via phone and email. If Sponsor is unable to contact the prospective winner within 24 hours of being contacted, or if the prospective winner does not meet eligibility qualifications, his/her prize will be forfeited and an alternate prospective winner shall be selected. The prize can be picked up at the California Coast Credit Union branch nearest to the winner between the hours of 9:00am-5:00pm or mailed to the preferred address provided by the winner. The winner will be asked to identify their first and last name via email and will then be asked for proof of identification upon receiving prize.

Liability/General Rules: California Coast is not responsible for any loss which may occur in connection with the “Aztec Fan Frenzy.” Entrants agree to hold California Coast harmless from any liability arising from participation in the Contest or the acceptance, receipt, possession, or misuse of the prize. California Coast and each of its officers, directors, employees, members, representatives and agents are not responsible for any negligence, claims, liability, injury, property loss, or other damages of entrants and/or winners arising from, or in connection with, acceptance, receipt, possession, or use/misuse of prizes awarded or participation in the “Aztec Fan Frenzy” Prizes cannot be substituted, assigned or transferred by winners. California Coast reserves the right to disqualify entrants who fail to follow these Official Rules or who make any misrepresentations relative to the Contest and redemption of prize.

Sponsor is not responsible for lost, late, misdirected, undeliverable, illegible, or incomplete entries, whether due to system errors or failures, faulty transmissions or other telecommunications malfunctions, entries not received resulting from any hardware or software failures of any kind, lost or unavailable network connections, failed, incomplete or garbled computer or telephone transmissions, typographical or system errors and failures, technical malfunctions, or otherwise. Sponsor may prohibit an entrant from participating in the Contest or winning a prize if, in its sole discretion, it determines that said entrant is attempting to undermine the legitimate operation of the Contest by cheating, hacking, deception, or other unfair practices or intending to annoy, abuse, threaten, or harass any other entrants or Sponsor. If, for any reason, this Contest is not able to be conducted as planned, including, but not limited to, by reason of infection by computer virus, tampering, unauthorized intervention, fraud, or any other causes beyond the reasonable control of the Sponsor which affect the administration, security, fairness, integrity or proper conduct of the Contest, then the Sponsor reserves the right, at its sole discretion, to cancel, terminate, modify or suspend the Contest. Personal Information: Information collected from entrant is subject to Sponsor’s Privacy Policy which can be found at calcoastcu.org/disclosures.

Arbitration: Except where prohibited by law, as a condition of participating in this Contest, entrant agrees that (1) any and all disputes and causes of action arising out of or connected with this Contest or any prizes awarded, shall be resolved individually, without resort to any form of class action, and exclusively, by final and binding arbitration under the rules of the American Arbitration Association (“AAA”) and shall be held at the AAA regional office nearest the participant; (2) the Federal Arbitration Act shall govern the interpretation, enforcement, and all proceedings at such arbitration; and (3) judgment upon such arbitration award may be entered in any court having jurisdiction. Under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental, or consequential damages, or any other damages, including attorney’s fees, other than entrant’s actual out-of-pocket expenses (i.e., costs associated with entering this Contest), and entrant further waives all rights to have damages multiplied or increased.

Taxes: Winners are responsible for all tax consequences (if any) of the prize.
