“Erykah Badu Concert Giveaway” CONTEST OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. PURCHASING PRODUCTS OR SERVICES FROM CALIFORNIA COAST CREDIT UNION WILL NOT IMPROVE YOUR CHANCES OF WINNING. EACH ENTRY HAS AN EQUAL CHANCE OF WINNING. The “Erykah Badu Giveaway” (Contest) begins 9:00 AM Pacific Daylight Time (PDT) on June 9, 2023, and ends 5:00 PM PDT on June 13, 2023 (Contest Period). By entering this Contest, entrants accept and agree to be bound by these Official Rules. Contest void where prohibited by law. California Coast Credit Union (California Coast) is the sponsor of this Contest (Sponsor). This promotion is in no way sponsored, endorsed, or administered by or associated with Facebook, Twitter or Instagram.

WHO MAY ENTER: Entrants must be at least 18 years of age, have valid government issued identification and valid tax identification number. California Coast employees, officials, and members of their immediate families are not eligible to participate in the Contest. Business entities are not eligible to participate. Contest is void in Puerto Rico, U.S. territories and possessions outside of the United States, and where restricted or prohibited by law.

HOW TO ENTER: Eligible entrants must follow the Cal Coast Credit Union page on Instagram (@calcoastcu), like the giveaway post, and leave a comment with one (1) different tagged account on the giveaway post. Eligible entrants may enter this Contest via Instagram or Mail. By entering the contest entrants accept being contacted by Cal Coast through Direct Messaging on Instagram. The entry methods are described below. All entries must be received by 5:00 PM PST, June 13, 2023. **Online Entry Method:** Eligible entrants must follow the California Coast Credit Union page on Instagram, like the giveaway post, and leave a comment with one (1) different tagged account on the giveaway post. **Alternative Method of Entry (AMOE):** Mail a 3” x 5” card with your Instagram handle along with, your first name, last name, complete address, city, state, zip code, home phone number (including area code) and email address (if any) to “Erykah Badu Giveaway” c/o California Coast Credit Union, Attn: Community Relations Dept., PO Box 502080, San Diego, CA 92150-2080. California Coast will not verify receipt of entries for entrants. All entries submitted become the sole property of California Coast and will not be returned. Sponsor is not responsible for lost, late, misdirected, illegible, or damaged AMOE entries. All AMOE entries must be received by 5:00 PM PST, June 13, 2023, to qualify.

Prize/Approximate Retail Value: First place winner will receive two (2) Erykah Badu concert tickets at the Pechanga Arena on June, 15 2023. The Approximate Retail Value (the “ARV”) of the two (2) Erykah Badu concert tickets is \$800. Based upon California Coast’s estimate of 250 entries, the odds of winning any prize are 1 chance in 250. Prize is not transferrable.

Selection of Winners: One (1) winner will be chosen on June 13, 2023 at 5:15 PM PST. The entry that is randomly selected by a random number generator will be selected as the winner and will receive two (2) Erykah Badu concert tickets at the Pechanga Arena on June 15, 2023. A panel of representatives from the Sponsor will judge the entries and resolve any disputes that may arise during the contest. All decisions by the panel are final. The winner will be contacted via direct message on Instagram directly after the drawing. If Sponsor is unable to contact the prospective winner within 24 hours of being contacted, or if the prospective winner does not meet eligibility qualifications, his/her prize will be forfeited, and an alternate prospective winner shall be selected. The prize must be picked up either at the corporate office of California Coast Credit Union between the hours of 9:00am-5:00pm or if the prize is virtual, it may be sent electronically via the AXS app. The winner will be asked to identify their first and last name in Instagram direct messages and will then be asked for proof of identification upon receiving prize. The winner of the drawing will be announced publicly on the Cal Coast Instagram story on June 15th, 2023, at 10 AM.

Liability/General Rules: California Coast is not responsible for any loss which may occur in connection with the “Erykah Badu Giveaway.” Entrants agree to hold California Coast harmless from any liability arising from participation in the Contest or the acceptance, receipt, possession, or misuse of the prize.
