CONTEST OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. PURCHASING PRODUCTS OR SERVICES FROM CALIFORNIA COAST CREDIT UNION WILL NOT IMPROVE YOUR CHANCES OF WINNING. EACH ENTRY HAS AN EQUAL CHANCE OF WINNING. The “Guess the Tees Giveaway” (Contest) begins 9:00 AM Pacific Daylight Time (PDT) on July 8, 2024 and ends 5:00 PM PDT on July 15, 2024 (Contest Period). By entering this Contest, entrants accept and agree to be bound by these Official Rules. Contest void where prohibited by law. California Coast Credit Union (California Coast) is the sponsor of this Contest (Sponsor). This promotion is in no way sponsored, endorsed, or administered by or associated with Facebook, Twitter or Instagram.

WHO MAY ENTER: Entrants must be at least 18 years of age, have valid government issued identification and valid tax identification number. California Coast employees, officials, and members of their immediate families are not eligible to participate in the Contest. Business entities are not eligible to participate. Contest is void in Puerto Rico, U.S. territories and possessions outside of the United States, and where restricted or prohibited by law.

HOW TO ENTER: Eligible entrants need to post a comment on the specific Guess the Tee Giveaway post found on the California Coast Credit Union Instagram page (@calcoastcu.) Your comment must tag another user and include your guess of the total number of golf tees in the bowl shown in the post image. Entries are accepted via Instagram or by mail, with the methods outlined below. All entries must be submitted by 5:00 PM PST on July 15, 2024. **Online Entry Method:** entrants need to post a comment on the specific Guess the Tee Giveaway post found on the California Coast Credit Union Instagram page (@calcoastcu). Your comment must tag another user and include your guess of the total number of golf tees in the bowl shown in the post image. Entries are accepted via Instagram or by mail, with the methods outlined below. All entries must be submitted by 5:00 PM PST on July 15, 2024. **Alternative Method of Entry (AMOE):** Mail a 3” x 5” card with your guess of the total number of golf tees in the bowl, your first name, last name, home branch, complete address, city, state, zip code, home phone number (including area code) and email address (if any) to “Guess the Tees Giveaway” c/o California Coast Credit Union, Attn: Marketing Dept., PO Box 502080, San Diego, CA 92150-2080. California Coast will not verify receipt of entries for entrants. All entries submitted become the sole property of California Coast and will not be returned. Sponsor is not responsible for lost, late, misdirected, illegible, or damaged AMOE entries. All AMOE entries must be received by 5:00 PM PST, July 15, 2024 to qualify.

Prize/Approximate Retail Value: First place winner will receive a \$100 gift card to the The Golf Bar. The Approximate Retail Value (the “ARV”) of the gift card is \$100. Odds of winning are based upon the number of entries. Based upon California Coast’s estimate of 250 entries, the odds of winning any prize are 1 chance in 250. Prize is not transferable.

Selection of Winners: One (1) winner will be chosen on July 16, 2024. The entry with the guess closest to the total number of golf tees, without going over the actual number in the display bowl will be selected as the first place winner and will receive a \$100 gift card to The Golf Bar. In the event of a tie, a random drawing will be held for the winners who tied and a winner will be selected. A panel of representatives from the Sponsor will judge the entries and resolve any disputes that may arise during the contest. All decisions by the panel are final. The winner will be contacted via Instagram direct message. If Sponsor is unable to contact the prospective Winner within 24 hours of being contacted, or if the prospective Winner does not meet eligibility qualifications, his/her prize will be forfeited and an alternate prospective Winner shall be selected. The prize will be sent via email.
